



BUCYRUS BICENTENNIAL PHOTO CONTEST - RULES & REGULATIONS

A. Dates of Contest

The contest will begin March 1, 2021 with the photo submission portion of the contest and ends April 30, 2021. On May 3, 2021 photos will be placed into an album on the FCBank Facebook page for the community to share individual photos. Winners of the Photo Contest will be selected on May 10, 2021 and announced on May 11, 2021 via Facebook.

B. How to Enter

Take a Photo or “Selfie” of yourself in front of the Bucyrus Bicentennial mural on the FCBank building, located at 105 Washington Square, Bucyrus, OH 44820. For group photos to be eligible, everyone must take the proper safety precautions and wear masks. Submit the photo directly to the FCBank Facebook page at www.Facebook.com/FCBankCommunity or through our website at www.FCBank.bank. To be eligible, be sure to add the hash tag #FCBankContest. Please note the following:

- a. Photos must be original and taken by the individual posting.
- b. No selfies of questionable content or in bad taste for a mixed audience, as determined by FCBank, will be accepted. If content is questionable, the photo will be removed and the submitter will be ruled ineligible. Questionable content could include, but is not limited to: people in various stages of undress, inappropriate gestures or sign language, inappropriate images or messaging on clothing, or inappropriate props.

C. How to Win

All eligible entries must be posted on the FCBank Community Bank Facebook page between March 1 and April 30 along with the hash tag #FCBankContest. Photos will then be placed in an album to be shared along with what is loved about Bucyrus. Winners will be selected May 10, 2021.

- a. One winner will be drawn at random from the list of submissions. This winner will receive a \$500 cash prize.
- b. The photo with the most shares will receive \$500 to be given to their 501(c)3 charity of choice*.

We know the tricks, so if there is any suspicion of foul play, your selfie will be disqualified. Please play fair and by the rules.
